MINUTES

The meeting was opened at 10.30am, by Barbara Evennett (our Co-Opted Committee IT expert) who briefly instructed all Zoom attendees on the meeting's procedures. All Zoom attendees should now mute their volume button and if they wish to ask a question during the AGM, please notify the Chair. Barbara then passed the Chair over to our President, Jacky Parsons who warmly welcoming all participants, both via Zoom and personal attendees.

13 zoom delegates, 5 Committee ladies and 13 attending delegates, thus resulting in 31 present. A quorum has been achieved; therefore, the AGM can officially proceed.

4. Minutes of the previous AGM in 2019

6. Treasurer's Presentation of Financial Report and Balance Sheet.

Treasurer Nancye Cullen presented the above report, (attached).

Important items of interest:

Sadly, this year our expenses have exceeded our income. Nancye explained that there were two reasons for this. Firstly, our decreased membership which in turn, affects our annual subscriptions and secondly, the increase in all our major expenses. However, this is the first time in a long while that this has happened. This report is from June 2021 to June 2022. The other reason for the downturn is low interest rates. Before we were receiving six to seven thousand dollars per year from our investments and now, we only get about \$1,200.00 or less. Nancye asked the audience if there were any questions on the financials. As there were no questions, Nancye Cullen moved that her Financial Report be accepted. Seconded by Lana Debnam (Committee). Carried.

7. Joining Fee and Annual Subscriptions

Treasurer, Nancye Cullen commented that the VWGA has not increased our membership fees since 2011, therefore we may in the near future have to look at this matter.

8. Public Liability Insurance Cover

Treasurer, Nancye Cullen spoke about our insurance increase from \$4,100.00 to \$5,200.00 in the previous year and now to our current quote which is about \$6,200.00 this amount reflects everything happening at the moment. To get the best deal with our insurance, we have gone to a broker to get the best value for our money. We must have Public Liability because we run tournaments. This covers the committee members going to and from the tournaments and getting to and from the office. The insurance also includes the office equipment, etc.

As our insurance is due on 30 November 2022 which will be approximately \$6,200.00, Treasurer, Nancye Cullen put a motion to the meeting for approval to pay our insurance on or before the end of November 2022. Seconded by Jenni Brown (Committee). Carried.

10. General Business

10.1 Beverly Park's Delegate, Jane Sherlock has a question from Jill Shield from Liverpool; Jane asked President, Jacky Parsons for Jill, why does the VWGA have their AGM on a Wednesday and not on a Friday like they used to years ago? Wednesday is the lady's playing day at Liverpool, and they can't attend this AGM.

Jacky's answer was that she didn't know the reason for the change and acknowledged that the AGM had been on a Friday in the past. However, Jacky did say that the VWGA Committee would discuss this matter when choosing next year's date.

10.2 Beverly Park's Delegate, Jane Sherlock stated that her club will be hosting a day next year because they got rained out this year. Jane asked if the VWGA has a cut off number should a host club have a shotgun start? Is it the club's decision or the VWGA's decision, so Jane can discuss this with the Board at her club.

Jacky's answer was reiterating Jenni Brown's (Tournament Manager) answer, being it is entirely up to the club, that the VWGA doesn't mind either way.

10.3 Beverly Park's Delegate, Jane Sherlock asked if the VWGA would consider Co-Opting some ladies who have extensive experience, who have played golf over many years, that could help the VWGA on the days we conduct tournaments. These ladies could check the score cards, see that they are signed or any other necessary job. We are only too happy to lend a helping hand, so it makes the management of the event faster and easier.

Jacky's answer was that we do get some ladies to help out at events, but the Committee will discuss this topic at our next meeting.

10.4 Cammeray's Delegate, Eve Bagnall stated that their club has lost at least half its course, like others, because of reclamation by the government. Cammeray will reopen next autumn, which is positively good news. The course will be 9 holes all par 3's. There will be new greens and a dam which is currently being constructed. Also, Cammeray is at present compiling their archive material. Eve hopes that the VWGA would support Cammeray when it opens next year. Eve went onto say that their membership is in a state of flux only because the ladies are not playing golf until their course reopens. Once the course is open, Eve will liaise with Virginia Hewett regarding membership.
